THINGS TO BE AWARE OF

- ✓ Review Important Summer Aid Information regarding eligibility for specific funds, and the impact to your fall and/or spring aid if you use these funds in the summer.
- ✓ **Summer financial aid is processed manually**; consequently, it is a very time consuming process. Applications are reviewed both by the date your application is received in the Financial Aid Office, and by the date you begin enrollment. Please allow a <u>minimum</u> of two (2) weeks to process your application.
- ✓ All requests for additional information will be sent to your Potsdam email account.
- ✓ Failure to respond to inquiries from our office may cause a delay in processing your summer aid.
- ✓ If you are enrolled for summer and you submit a FAFSA, you will be awarded Pell, if you are a Pell eligible recipient based on FAFSA data and summer enrollment. You do not have the option to take a loan (federal or private) in place of the Federal Pell grant. You do have the option to decline Federal Pell to reserve funds for future use.
- ✓ Summer aid eligibility is based only on the sessions in which you are enrolled. We are not permitted to award aid for periods of non-attendance.
- ✓ Summer aid eligibility is based on an average cost of attendance. If you have expenses that exceed the average cost, you may want to submit a Cost of Attendance Adjustment Form, which is available in BearPAWS.
- ✓ You must respond to your summer financial aid Award Confirmation in BearPAWS and accept or decline the loans we have offered before any loans will disburse.
- ✓ Federal loan funding is ONLY available to you if you are enrolled in six (6) or more credit hours. If you are initially registered for six (6) credits, but drop credits, you will no longer be eliqible for a federal loan.
- ✓ The earliest a summer loan will disburse is mid-June; it may not disburse until even later; please plan accordingly.
- ✓ Any change to your summer enrollment may affect your aid eligibility. If you make changes to your enrollment <u>after</u> your summer aid has been calculated, there will be a delay in determining your summer awards based on your new enrollment.
