Please remember if you need anything from us or just want to stop by and chat, come by the Student Success Center where our office is located!

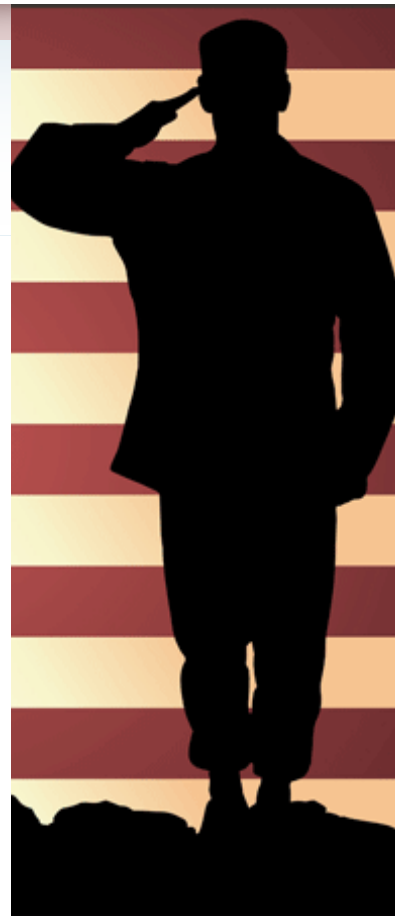

VA Announces Rollout of Secure Veteran Health Identification Cards

WASHINGTON – The Department of Veterans Affairs (VA) today announced the phased roll out of newly designed, more secure Veteran Health Identification Cards. The new cards are distinguished by additional security features and will have a different look and feel.

In addition to being more secure, the card has been transformed into a Veterans Health Identification Card (VHIC). Similar to a typical health insurance card, the VHIC displays the Veteran's Member ID, a new unique identifier, as well as a Plan ID, reflecting the Veteran's enrollment in VA health care.

"VA is committed to providing high quality health care while ensuring the personal security of Veterans," said Secretary of Veterans Affairs Eric K. Shinseki. "These new identification cards are an important step forward in protecting our nation's heroes from identity theft and other personal crimes."

The VHIC is personalized to display the emblem of the Veteran's branch of service. It also provides features that make it easier to use, such as the addition of "VA" in Braille to help visually impaired Veterans, and the printing of VA phone numbers and emergency care instructions on the cards.

The card replaces the Veteran Identification Card (VIC), which was introduced in 2004. As part of a phased rollout, starting this month, the card will only be offered to newly enrolled and other Veterans who have not been issued a VIC. Then, in early April, VA will begin a three month effort to automatically issue the more secure VHIC to current VIC cardholders. VA recommends Veterans safeguard their VIC as they would a credit card, and cut up or shred the card once it is replaced. While not required to receive VA health care, all enrolled Veterans are encouraged to get a VHIC.

American flags made in China now banned in U.S. military

ROHNERT PARK, Calif. -- Soldiers carry them into battle, fly them high over foreign bases, and triumphantly carry them in processions, but those stars and stripes, until now, have often been made in China.

That irony spurred North Bay Congressman Mike Thompson to write legislation requiring flags purchased by the Department of Defense be 100 percent "Made in America," reports CBS San Francisco.

That legislation is now law, signed as part of the 2014 omnibus appropriations bill.

"I thought it was appalling our Department of Defense would have flags made in other countries," Thompson said. "But it's also important because we need to be making more in America."

While the military flag rule passed, a similar bill requiring all government-purchased flags be made in the U.S. has repeatedly failed. The change isn't cheap. Chinese-made flags cost significantly less than all-American ones.

The new requirements apply the existing Berry Amendment passed in 1941 to flags. That amendment bans the Defense Department from buying food, clothing, military uniforms, fabrics, stainless steel, and hand or measuring tools that are not grown or produced in the United States, except in rare exceptions.

"I am proud to have worked to pass this law so that our men and women in uniform never have to fight under a U.S. flag made overseas, and so that our Defense Department never again spends American tax dollars on a U.S. flag made overseas," said the Vietnam War veteran and Purple Heart recipient.

Thompson toured North Bay Industries on Tuesday. The Rohnert Park company makes thousands of flags each year, mainly for the Department of Veteran Affairs, which was already required to source memorial flags made in the United States with American-only materials.

North Bay Industries is a vocational rehabilitation center dedicated to assisting mentally, physically, and developmentally disabled adults through participation in agency-sponsored training, housing, and employment programs.

Thompson had visited the Rohnert Park facility last year and found out that not all flags purchased by the military were being made in the U.S., which he said prompted the need for the legislation.

House Votes to Strengthen G.I. Bill, Ban Bonuses for VA Senior Execs

WASHINGTON, DC – Today, the U.S. House of Representatives passed H.R. 357, as amended, the G.I. Bill Tuition Fairness Act of 2013, a bipartisan bill introduced by Chairman Miller and cosponsored by Ranking Member Mike Michaud. The bill would enable G.I. Bill recipients to receive in-state tuition rates at any public college or university in the country, not just those in a veteran's state of residence. The bill also contains a number of other provisions designed to enhance veterans benefits and bring more accountability and efficiency to the Department of Veterans Affairs, including:

- A five year ban on performance bonuses for VA Senior Executive Service employees
- An extension of Veterans Retraining and Assistance Program job training benefits through May 31, 2014. The program is currently set to expire March 31, 2014
- Stronger infectious disease reporting requirements for VA hospitals
- A requirement for VA health officials to obtain the consent of patients before electronically monitoring them in private patient areas
- More comprehensive reporting requirements for VA employees traveling abroad

Following House passage of H.R. 357, Chairman Miller issued the following statement:

"The men and women who served this nation did not just defend the citizens of their home states, but the citizens of all 50 states. This bill will ensure our veterans' educational benefits reflect that important principle. And because H.R. 357 saves the government money, it's a win for taxpayers as well as veterans.

"House passage of this bill is also a big step forward for all who are fighting to instill some much-needed accountability at VA. In response to a rash of media reports documenting how numerous VA senior executives have received sizeable 'performance' bonuses despite presiding over significant increases in benefits claim backlogs and even preventable veteran deaths, we've been asking VA for months to conduct a top-to-bottom review of its performance appraisal system. So far, VA leaders have refused, and until we have complete confidence that VA is holding executives accountable – rather than rewarding them – for mistakes, no one should get a performance bonus. Period. This bill will ensure that is the case." – Rep. Jeff Miller, Chairman, House Committee on Veterans' Affairs

Parking Fee Waivers: Student must be a Veteran who has received an honorable discharge from their respective branch of military service. In order to receive a parking fee waiver, present a copy of your DD-214 to the University Police Office showing your honorable discharge.

Recreational Facilities Fee Waiver: Submit a copy of your DD-214 to Patrick Massaro, Military & Veterans Student Services Coordinator, Sisson 128C.

Possible credit for military training and experience: In order to have your military transcripts evaluated, please utilize the Joint Service Transcript website (<https://jst.doded.mil/>) and have your military transcript sent to SUNY Potsdam Admissions office.

SALUTE Veteran Honor Society Requirements

The SALUTE Veteran Honor Society is meant to provide Veterans of the US Armed Forces with support, bridges from undergraduate education to graduate school or veteran-friendly professional life, and as means of academic recognition.

To qualify for SALUTE, students must meet the following requirements:



- Minimum cumulative GPA of 3.0 for Undergraduates (3.5 for Graduate Students)
- Minimum 12 credits earned at SUNY Potsdam
- Must have served, or are currently serving in the US Military, National Guard or Reserves
- Submission of DD-214 (reflecting honorable discharge), Discharge from Active Duty or a copy of Military Orders Completed Application to SALUTE

- \$20 application fee
