- Met with campus technology representative in Fall 2023 to discuss installation of software to Clear Touch Panel to enable full capabilities and ability to provide training I agreed to send the contact information to the technology department for obtaining software update
- Contact information was sent
- Spring semester: contacted technology department in follow up contact had not been made with Clear Touch company; I agreed to contact company; however, training opportunity timing with BOCES had passed
- Contact has been made with Clear Touch company for fall 2024 follow up on software installation; will collaborate with technology department to get it installed and schedule subsequent training by Spring 2025.
