

Faculty Senate Meeting September 25, 2025 Minutes

Meeting called to order by Jessica Pearson at 4:03 p.m.

- 1. Welcome
 - 1.1. Welcome everyone to first faculty meeting
 - 1.2. Welcome anyone who is new, thank you for being here
 - 1.3. Hoping SGA president will be here so she can be here and leave right away
 - 1.4. Comments in chat are fine, but keep questions and discussions out of chat, email Tanya Hewitt or Sheila Neal to speak on your behalf
- 2. President Suzanne Smith reported
 - 2.1. Welcome everyone to Fall 2025, welcome to Susan Perkins
 - 2.2. A few updates based on questions and comments that have been received
 - 2.2.1. What's happening with Dunn hall space
 - 2.2.1.1. It's fenced off, starting to seed space, 14 trees are going in around perimeter, wont see much change for awhile -- about 6 weeks away from fence going down
 - 2.2.1.2. Students will be asked, WISER center will be asked
 - 2.2.1.3. It will be a green space, but suggestions being received, it will be a usable space for our campus -- feel free to send ideas to President
 - 2.2.2. Questions about the budget and seems to be confusion around the 15% budget cut needed to reach our deficit
 - 2.2.2.1. Information can do but be painful, can do but catastrophic
 - 2.2.2.2. We are figuring out what we can do within the painful category
 - 2.2.2.3. No department was told they will receive a 15% cut
 - 2.2.2.4. In middle of conversations about this
 - 2.2.3. Campus update on October 30 at 4:00pm
 - 2.2.4. Are doing an event on October 24, Dunn time capsule will be unveiled at the Dunn event
 - 2.3. New SUNY Initiative Momentum approach
 - 2.3.1. General ideas, each first-year student should have 30 credits in first year, degree maps, they should have a course in their major in their first year. SUNY is rolling this out, we will find out more about the timeline soon. We will be asked to track these things, and FASFA, and completion rates.
 - 2.4. Final thing, reminder, mentioned at the opening, campus professional days January 12 through 14th. Feel free to reach out to officers, to ask for feedback on this

- 3.3. Working on trying to get SGA out there more, working on a Publicist position
- 3.4. Not too much going on, things are running smoothly

- 4. Provost Susan Perkins reported
 - 4.1. Intro, bio, pleased to see that I have met most of you, if I have not met you, happy to meet departments
 - 4.1.1. Am a Potsdam grad, 1993, was a student athlete, rode on equestrian team, tennis team, and worked a lot in Maxcy
 - 4.1.2. Did my PhD and University of Vermont
 - 4.1.3. 2020 became a Dean at City College of NY for over 5 years,
 - 4.1.4. Wanted to come to Potsdam, was a member of Alumni board
 - 4.2. Campus commitment to student success is a culture here, who we are and what we do here, and the on campus experience
 - 4.3. Academic Momentum looking forward to working with campus on those
 - 4.4. Once a month meets with cabinet, and every other week meet with committee to work on student success NACE Competencies; Fields of study approach builds in competencies based on degree planning, helping students craft their best plan to reach the hidden work force that 83% of jobs are part of; Scott and Ned are going to be here on campus on October 24th; hope that you can come. Some concepts are part of A&S reorganization
 - 4.5. A&S Reorganization is helping us right size our campus, and opportunity to hone our curriculum
 - 4.6. Working with Alan Hersker, putting in new programs, letters of intent, a little frustrated with the slowness of SUNY System
 - 4.7. Had a meeting with Dean of Lewis health science at Clarkson, good opportunities with partnership
 - 4.8. Assessment -Potsdam is doing a fantastic job with it. Summit in January
 - 4.9. Two questions forwarded
 - 4.9.1. Evaluation of new advising staff will be handled by the Provost office
 - 4.9.1.1. if you are hearing of things, let Provost know
 - 4.9.1.2. They have a chance to talk to students in a certain way
 - 4.9.2. Question about Final Exam, we are required to have 15 weeks of contact, 14 weeks of in class time, 1 week of final exam; any exception of this should go to a Dean keep it simple
 - 4.9.2.1. Policy now is robust
 - 4.9.2.2. Please ask any questions

 - 4.10.1.1. Response the advising will have to be assessed, welcome input from faculty and staff

- 4.10.2.1. If class meets in person, but the final exam is virtual -- will look into this, it makes the class hybrid, if it has been an in person class, I would think the final needs to be in person as well

 - 4.10.3.1. Working on this, asking for feedback on the ads, hope is that we are moving forward with the advertisements by early October, timeline will be similar to the Provost search, but maybe a little earlier

 - 7.1. Laura Brown presented on program, goal is to ensure we are competitive, we are bringing students in, and reduced redundancies, merged courses, created new courses to ensure students are well-prepared
 - 7.2. Chairs of APCC and BAC to speak on this
 - 7.2.1. Jan Trybula presented APCC voted to move it forward
 - 7.2.1.1. There is concern older programs are double degree programs, if a student is partway through, students will have trouble picking up the other major

- 7.2.1.2. Wondering if students need to be warned 4 year programs are packed, and if a student needs to repeat a course, it could put them in an overload, and be cautious the way the schedule have been put forward.
- 7.2.1.3. For a number of the subjects they are scaffolded by advising, they do not have prerequisites built in
- 7.2.1.4. Referring back to revised impact statements, we are hoping everything follows, students be assigned an advisor
- 7.2.1.5. Impact statements about working groups, we hope this happens
- 7.2.2. Savit Hanspal BAC, committee met, financial impact, had a conversation with Laura Brown about these; looking at the answers we were satisfied
 - 7.2.2.1. Questions about second majors not being counted as far as faculty lines; if adjuncts or additional faculty are required
