Math, science, and technology play a major role in our lives today. The North Country Science and Technology Entry Program (NCSTEP) would like to encourage your student's interest in these fields through academic support services and enrichment activities. NCSTEP will help to support your student throughout his/her time at BOCES and on to college or the workforce.

All program offerings are FREE to NCSTEP participants and include, but are not limited to:

- > Financial support for college course credits, exams, and certifications
- > Stipends paid for research, internship, and job-shadowing experiences
- > Scholar Dollars for academic achievement (honor and high honor roll)
- > Financial support for educational items including scrubs, stethoscopes, and other supplies
- Summer Research Week
- > Cover costs associated with conferences or workshops, including registration fees and travel
- Providing access to Kaplan or other test prep sites
- > SAT and ACT preparation and fee waivers
- > College application and financial aid assistance
- Campus visits

NCSTEP is housed at SUNY Potsdam and currently serves approximately 235 students in the Madrid-Waddington, Massena, Parishville-Hopkinton, and Salmon River school districts. We are excited to be adding SLL BOCES to that list! Our goal is to increase the number of historically underrepresented and income eligible students prepared to enter college in majors involving math, science, technology, engineering, health related fields and the licensed professions (Please see enclosed New York State income eligibility chart for economic guidelines. If your student is financially eligible for free/reduced lunch, he or she is eligible for NCSTEP).
