Fall, 2021 COVID-19 Plans & Updates

Academic FAQs/Fall 2021. While the following guidance may continue to change over the course of the semester, as of today the following FAQs are offered (with thanks to everyone who provided these thoughtful questions and informative responses).

--Can we be 100% certain that everyone in our class is vaccinated?

- No. Even with the vaccine mandate in full effect, there may be students with an approved religious or medical exemption in your face-to-face classes.

--What are students being told when they (1) receive a positive test result and (2) when they are told that they have been exposed or learn that they have been exposed?

- Students who test on campus are able to access their own results just like employees can through the Quadrant Lab web site. If a student tests positive, they are told to isolate in-place for 10 days. Students who live on campus are told to self-isolate in their current room until Residence Life contacts them about moving into the isolation area. Students also have the option to travel back home, provided they have a safe way to do this and a safe place at home for their isolation. Students are told it is their responsibility to notify their teaching faculty about their status.

-- What is considered exposed/a close contact, who is being contact traced, and how is it being decided who needs to quarantine?

- The campus is following guidance about the contact tracing process from County Public Health. There is no one universal definition of “close contact” as each circumstance is

evaluated on its own merits. Generally, Public Health uses 6-feet for 10 minutes of exposure, or 15 minutes over a 24-hour time period, as the basis for determining if close contact has happened. If someone has been identified as a close contact but is fully vaccinated and asymptomatic, they are not required to quarantine and should test three to five days after exposure.

--What should faculty do if a student informs them that they are in mandatory quarantine or isolation?

- If a student reaches out to a faculty member to let them know that they are in mandatory quarantine/isolation, and the faculty member wants verification, do NOT try to contact Student Health (SHS cannot provide that information to faculty or staff). However, the faculty member can ask the student for verification—the student would have received a communication from Deb Murray. This message can be screen-shot by the student, for example, and sent to the faculty member as verification.

--Are faculty required to provide students with a virtual alternative to instruction if that student is in mandatory quarantine/isolation?

- When a student misses a class because they are in mandatory quarantine or isolation, it is the expectation of this College that faculty members accommodate for those students in a manner and modality that is appropriate for that specific class. The College is not mandating a specific type of modality, but is instead allowing for flexibility. Faculty members should be applying the same policy regarding late assignments for students who are out with COVID-19 as they would for any other illness or hospitalization; these policies should have been included in the class syllabi.

--Can faculty change meeting times or add additional class sessions to make up for time lost due to quarantine/isolation?

- No, faculty (or administrators) cannot change or add meeting times of classes from what was posted in the schedule. In addition, if a class is posted as asynchronous, we cannot retroactively add meeting times, as this would likely result in conflicts with other courses students are registered to take.

-- What percentage of faculty are teaching remotely?

- The vast majority of our classes are being held face-to-face. Each campus is required by SUNY to submit a monthly report on the number of courses being taught in various modalities. Our most recent reported data include the following:
 - Number of Online undergraduate level sections: 56
 - Number of Hybrid undergraduate level sections: 2
 - Number of In-Person undergraduate level sections: 884
 - Number of Online graduate level section: 34

- Number of Hybrid graduate level sections: 1
- Number of In-Person graduate level sections: 61

--Is SUNY negotiating with the unions to make Covid vaccinations mandatory?

- At this time, there are no agreements with the unions regarding mandatory vaccinations for COVID-19 and we are not aware of any forthcoming. However, all employees who have chosen not to submit proof of full vaccination to HR are required to participate in weekly COVID-19 testing until at least December 31, 2021. Those employees who have submitted proof of full vaccination can also participate in weekly testing, if they so choose.

--What religious exemptions are allowed and what information is required from students to get one?

- Information regarding the religious exemption is included in the request form, which is posted online: <https://www.potsdam.edu/sites/default/files/inline-files/ReligiousExemptionVaccine.pdf>.

--What is the plan for the Spring semester to be proactive on catching and preventing an outbreak at the beginning of the semester? For example, will we start the semester online for first two weeks and then move to in-person?

- The ERRG has not yet begun conversations regarding the Spring, 2022 semester, as there are still many unknowns regarding COVID-19, its variants, and whether there will be any ongoing or new surges in cases. However, the ERRG will continue to monitor data from our campus, county, and state, and will be following guidance from SUNY and the state regarding spring reopening plans. It is likely that the campus will continue its successful practice of testing all students upon arrival to campus, and requiring weekly testing for all unvaccinated students (those with approved exemptions).

At the present time, there are no plans to begin the Spring, 2022 semester virtually.

Contract Tracing/Classroom Attendance. I want to extend my sincere thanks to everyone who assisted in creating and gathering classroom seating charts and rosters for use in contact tracing. This was a huge task, which is already having a substantially positive impact on the ability of the contact tracers to respond when there is a positive student case. ***Please be sure to remember to continue to keep attendance for every face-to-face class session.*** With accurate information, we are able to reduce the number of students impacted if there is a positive COVID-19 case on our campus. (Conversely, without current seating charts and attendance records, it is highly likely that every student in your class would need to self-quarantine if a student tests positive!)

PPE Available. A limited number of clear face masks are available for instructional faculty from Environmental Health and Safety. If you are interested, complete the [PPE Order Form](#) and email your request to ppe@potsgdam.edu. In addition, the campus is trying out face mask inserts to assist faculty in speaking while wearing a face covering. If you are interested, email ppe@potsgdam.edu to request an insert.

Events and Food. Questions have been raised regarding our campus' policy related to food at on-campus face-to-face events. Food is allowed, but with the following caveats:

- Provide commercially prepared, individually packaged foods that are single serving.
- Work with PACES for a catered event (no self-serve options are permitted).
- Any event with food will require proof of vaccination for entry. Unvaccinated participants may not have food at events (grab and go is permitted).

Updates from Human Resources. In an effort to continue to keep our campus community as safe as possible, *all employees* must participate in COVID-19 testing on **October 18**, regardless of vaccination status. This is in alignment with the agreements between the State of New York and CSEA, UUP, PEF and PBA. You will receive an email reminder the week prior regarding this mandate. On **October 18**, there will be a Human Resources representative in the Raymond Hall lobby should you have any questions. Additional information regarding COVID-19 testing can be found [here](#).

Effective October 18, we will be transitioning from the saliva test back to the swab test. Therefore, if you have extra saliva tests please bring them to the Raymond Hall lobby on any testing date prior to October 18. There will be swab tests available the week prior so that you can administer the swab test on October 18. You **MUST** register your test with [SUNY Upstate Medical](#). You **MUST** put your full legal name and date of birth on the test tube. In addition, due to the Monday holiday on October 11, COVID-19 testing will take place on **Tuesday, October 12**.

Campus Updates

Starfish. We are very excited to begin using *Starfish* as our new platform for Progress Reports (now called Progress Surveys), advising and tutoring appointment scheduling, and coordinated student support. Starfish replaces the Navigate platform, which was turned off on September 28th. Users can begin working in [Starfish](#) immediately. See below for virtual training opportunities.

A [Starfish page on the campus website](#) has been set up with resources that will help get users familiar with the new software. Please take a moment to visit the site and view the brief training videos. More resources will be posted as the semester progresses.

Our regular campus-wide early academic alert process (*Progress Surveys*) began on September 27th and be open until **11:59pm on October 10th**. An announcement has been sent to all faculty about the process, and there is an informational tutorial video linked on the faculty section of the Starfish page on the campus site.

In addition to Progress Surveys, faculty and staff can raise flags and give kudos to students throughout the semester using Starfish. Kudos are a great way to encourage students who are doing well. Flags will initiate a notification and workflow to ensure students are connected with the proper resources for prompt follow-up.

Later in the semester, faculty and staff are encouraged to schedule and track their Spring, 2022 advising appointments in Starfish. Appointment summaries and notes from Navigate have been imported to Starfish to help provide a seamless transition.

Fall Break. Fall Break is just around the corner! As published in the [Academic Calendar](#), break begins on **Friday, October 8th**, at 10:00pm; classes resume on **Wednesday, October 13th** at 8:00am. Please note that assignments cannot be due during break, because classes are not officially in session. I hope that you, and your students, enjoy the much-deserved time off!

Updates from the Registrar. As a reminder, advising begins on **Wednesday, October 20th**.

The registration dates will be as follows:

- November 9: Graduate Students
- November 10: Undergraduate Seniors
- November 12: Undergraduate Juniors
- November 15: Undergraduate Sophomores
- November 16 Undergraduate Freshmen
- November 18: Transfer Students

Questions have also arisen regarding the process for *submitting late grades*. We will be implementing Microsoft Flow for this process, using the following steps:

- Faculty member completes Flow with all late grades and rationale as to why they are late
- Form goes to Dean (or representative) for review and approval
- Form goes to Registrar's Office for processing

The best option, however, is to make sure that grades are submitted on time. Processing late grades is very time consuming, and also impacts academic standing processing, issuing of diplomas, transcripts, etc.

Correction: Internship Supervision Compensation Pilot. Please note that the language related to the banking of course releases was incorrect in previous editions of this Newsletter. The correct language should read as follows:

1. **Banking towards course releases.** Once a faculty member has supervised 15 internships of at least three credits each, that person is eligible for three credits of course release (20 internships supervised would result in a four-credit course release).

The purpose of this pilot is to recognize the labor involved in creating and supervising internships, which are integral to our students' academic and professional success, and to encourage programs to intentionally expand their use of this successful high impact practice.

With this pilot program, faculty who are running internships that are integral to their program requirements have the flexibility to choose compensation either in the form of professional development funds or time (through course releases). It is important to note that this pilot program plan is intended to fill a gap in those instances where there are no existing mechanisms for supporting faculty who supervise internships (for example, this does *not* apply to Student Teaching supervisors, whose work is recognized in the assigned course load). This pilot program also does not include summer internships, for which faculty already receive compensation for internship supervision.

Scantrons/Exams. Just a quick reminder that the campus is not able to provide support for Scantroning, including the use of "bubble sheet" paper/pencil exams. Interested in an electronic alternative? Check out the resources included in the following:

Study Abroad Update. During this time of global uncertainty, we are eagerly anticipating a return to international travel! SUNY communications continue to be monitored for updates on

Spring, 2022 study abroad. While spring travel may be possible, Fall, 2022 is much more likely. Until we have additional clarity or direction from SUNY, please note the following:

- **Travel Courses:**
 - There will be no SUNY Potsdam international travel over Winterim, 2022.
 - Applications for SPRING, 2022 travel courses will be accepted until **October 15, 2021**.
 - Applications for SUMMER, 2022 travel courses will be accepted until **November 15, 2021**.
 - Applications for FALL, 2022 travel courses will be accepted until **April 1, 2022**.
- **Student Engagement:**
 - A new portal for study abroad scholarships, in collaboration with Financial Aid, will be available to students beginning in Spring, 2022.
 - Students interested in study abroad can attend an online information session (listed in Get Involved) or make an appointment via Handshake. *Jenica Rogers* and *Tom Baker* are advising students on how to get started on researching their options.
- **Online International Education:**
 - The Loughheed Center for Applied Learning can help connect students to international experiences despite our challenges with travel.
 - A new Global Virtual International Internship program is now available to students (see pg. 23 of this Newsletter).
 - *Sharmain van Blommestein* (English & Communication/COIL Coordinator) can assist any faculty interested in pursuing a COIL course.

Breaking Barriers Grant. The Crumb Library, working with *Nancy Lewis* (Sociology & CJ) has received a grant for \$8,770.00 to support the creation of a computer lab at the Riverview Correctional Facility at Ogdensburg. This grant, entitled *Breaking Barriers: 21st Century Education & Information Literacy Opportunities in Prison*, is the first step for our libraries to deliver Information Literacy via a special JSTOR database access program at Riverview. Funded by the Northern New York Library Network, the grant is intended “to support a member organization's capacity to contribute to shared local efforts, participating in collective goals and/or priorities of their greater community.”

HappyLight Compact Natural Spectrum Lights. This is a reminder that both the Crumb and Crane Libraries have lights that students can check out for two weeks at a time. These light therapy kits can help improve mood for those that suffer from Seasonal Affective Disorder (SAD). Each box includes instructions and guidelines for best practices for using the light. The lights are available on Reserve at both libraries.

Diverse Voices Research Strategies: Decolonizing the Library. Librarian *Marianne Hebert* has extensively researched and created a guide for students and faculty that addresses the challenges faced by students and researchers when trying to locate and integrate diverse voices in their instruction and research. Topics include race, ethnicity, and social justice; gender and sexual orientation; immigration and xenophobia; health care, disability, and stigma; religion and discrimination; and poverty and economic disparities. 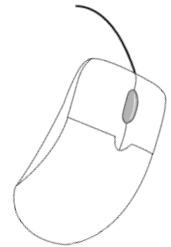
Diversity, Equity, and Inclusion within SUNY Libraries: Inclusive Manager's Toolkit. *Lauren Jackson-Beck* (Director of College Libraries and Archives) is participating in a SUNY Libraries professional training initiative designed to support better leadership through effective and inclusive management. SUNY Libraries and OLIS have supported 10 librarians throughout the system to participate in the *DeEtta Jones Inclusive Manager's Toolkit*. The ten-week course includes learning inclusive skills and language; leadership philosophy that integrates DEI; and examining privilege, communication across cultures, and other tools to create a DEI supported,

Daniel F. Garde Donation for Crane Library. Crane Library has received the *Daniel F. Garde Collection of Operas and Symphonic Music* from Daniel F. Garde. Mr. Garde has been an avid collector of opera performances and symphonic music on recordings. "The collection is especially strong for the breadth and variety of the opera repertory, and for the singers, instrumentalists and conductors since 1980," says Distinguished Crane Librarian *Edward Komara*, adding "it helps Crane Library catch up on recent performers whose recordings we could not collect previously." The scope of the collection includes approximately 3,850 LPs and laserdiscs; 10,000 CDs, 340 DVDs, 300 commercial videotapes, 300 commercial audiotapes, and 600 books; a wide array of audio equipment, shelves and supplies; and 14 framed autographed items signed by internationally renowned singers and musicians.

Updates from the CCI

Online Faculty Fellows. The *Online Faculty Fellows* are embarking on visits to all departments to showcase the number of ways that they can be of support to the faculty regarding online learning. Part of the conversation will include information about preparing for the switch to a new Learning Management System (LMS). The Fellows will be reaching out to department chairs in hopes of getting on upcoming department meeting agendas for 15-20 minutes. Thank you for your continued support of this peer-driven professional development program.



Knowmia Upgrades. As users may have noticed, Knowmia has recently made changes to how videos and folders display in your library. Also, the *Launch Capture* app has new features that may require you to do the following (do this in a Chrome browser):

- Go to <https://potsdam.techsmithrelay.com/>.
- Select the Sign in button on the page and sign in using your campus username and password.
- Select the Launch Capture button.
- Select the Open TechSmith Capture button in the pop-up window.
- The campus sign-in page will open (again); sign in using your campus username and password.
- Capture should launch successfully, and you shouldn't have to do this again.

If you have trouble, you should normally request help directly from Knowmia. However, TechSmith's sign-in system has recently changed as well, and our campus' Knowmia account is not directly linked. The system should be updated soon, but in the interim, please forward all Knowmia issues to cci@potdam.edu and staff will generate a Knowmia support ticket for you.

Course Surveys (a.k.a. Course Evaluations). Course surveys, delivered through the EvaluationKit (EK) online system, must be requested through BearPAWS and are due three weeks before the last day of classes (for Fall, 2021 the deadline is **November 19th**). EK surveys have replaced Scantron and Moodle course evaluations. For complete guidelines, please visit the [Course Surveys](#) webpage.

- For courses that conclude before semester's end, also submit the Mid-Semester Course Survey form.
- Surveys are available to students a week before the last day of classes.
- Faculty may add "custom" questions a week before the survey is active (optional).
- Student survey notifications are made in Moodle and by email.

Note: Carefully follow the request form instructions (don't skip step 2). When successful, instructors will receive a confirmation email. For training tutorials, please visit the EvaluationKit section of [Tech Tools](#).

Applicants for the Coordinator position should have experience teaching in the content and skill areas and ideally have experience teaching WAYS 103. Applicants should have the support of their department chair. The WAYS 103 Coordinator receives one three-credit course reduction per academic year, pending budgetary approval. The WAYS 103 Coordinator's "home department" receives equivalent replacement compensation, if needed, so that teaching and advising responsibilities are adequately covered. The WAYS 103 Coordinator reports to the Potsdam Pathways Director, will serve a three academic year term starting in August 2022, and be eligible for reappointment as Coordinator for one additional three-year term. WAYS 103 coordinator responsibilities include:

- Recruit and train faculty to teach WAYS courses in consultation with *Pathways* Director and Assistant Director.
- Assist faculty with WAYS course development/approval.
- Coordinate workshops and professional development opportunities for faculty teaching WAYS courses.
- Serve on and actively participate in the work of *Pathways* Curriculum Committee.
- Lead assessment efforts for determining that the courses and the requirements are meeting WAYS objectives.
- Teach WAYS courses, when possible (although they need not be teaching WAYS courses during their term as Coordinator).
- Actively engage in professional development opportunities to keep current with best practices in pedagogy and assessment in their content/skill specialization.
- Organize meetings of WAYS instructors throughout the semester to facilitate further faculty development and monitor student progress.

WAYS Course Release Procedures. As part of the Pathways WAYS series, WAYS courses (101, 102, 103, 301) require additional faculty training, mandatory meetings and workshops, and the submission of assessment data each semester. In recognition of these additional responsibilities, faculty accumulate one credit toward a course release for each semester they teach a WAYS course. MOUs acknowledging these additional responsibilities are signed by faculty each semester.

Faculty who teach multiple sections of the same WAYS course in a given semester will only earn one credit for that semester. Faculty who teach different WAYS courses in a given semester and will earn one credit for each type of WAYS course (i.e., 101, 102, 103, 301).

When faculty have accumulated three credits, they may be eligible for a three-credit course release.

- Faculty must complete the semester and all its obligations before earning the credit. The Pathways Assistant Director will maintain a spreadsheet that will be updated at the end of each semester.
- Given the course scheduling timeline, faculty will likely not be eligible to take a course release in the semester immediately following the accumulation of three credits. Exceptions to this may be considered in consultation between the department chair, dean, and Pathways director. Determinations will be based on faculty workload and the scheduling needs of the home and WAYS departments.
- Course releases may be used for regularly taught WAYS courses or for courses taught in the faculty's home department. This will be determined through consultation between the department chair, dean, and Pathways director.
- In most cases, course releases must be taken within three semesters of being earned. Faculty cannot "bank" these credits. Exceptions to this may be considered in consultation between the department chair, dean, and Pathways director.
- Course release credits expire after five years, if faculty do not (1) use them (2) continue to teach WAYS courses and/or (3) renew their WAYS course (which should be done every three years).
- This policy is subject to change or retraction if warranted by campus fiscal considerations.

Interested in Teaching a WAYS course? Pathways and the WAYS courses are fortunate in that we have had almost 65 faculty teach at least one section of WAYS 101, 102, 103, or 301 (this list includes faculty who were part of the initial pilots of these courses). The WAYS courses are taken by all SUNY Potsdam students, with 101, 102, and 103 being taken in the first year. Crane students have been added to Pathways general education as part of our second year of rollout. Because of the additional students from Crane and changes in the needs of home departments, we still need more faculty to teach WAYS courses. We would especially love to invite more faculty from Crane and SOEPS.

WAYS courses typically take a year from initial development to actual teaching—this time is spent on developing the course, being part of the professional development workshops, getting the courses approved by PPCC, and getting the courses into the schedule. More information

- Clarity of the description of the initiative
- Plan for sharing “best practices” related to the initiative to the broader campus community

How many awards will be made?

It is anticipated that two awards will be made each year.

How will awardees be recognized?

Awardees will be recognized in the Provost’s Corner Newsletter. In addition, the awarded unit/department will be provided with \$500 to be used towards professional development for the academic year in which the award is made (awards will not be able to be “banked” for future years). If an individual faculty/staff member is selected, the amount of the award will be \$250 for that individual or \$500 for the individual’s department/unit, depending on the preference of the finalist.
