Goals: The goals for any health care delivery system are derived from the values and needs of those who participate in the system. SUNY Potsdam is a student-centered, residential campus committed to "offering, through appropriate means and methods, excellent baccalaureate, master's and continuing education opportunities in the arts and sciences and selected professional disciplines."
